

RECOMMENDATIONS

- No Addition & Renovation in respect of building constructional side & storage side must be made without prior permission of Deputy Director (South Zone), W.B.F & E.S.
- 2. Means of Escape must keep free from any obstruction.
- 3. One stair Emergency Exit must be provided for evacuation in case of Emergency.
- 4. Safe distance must be maintained for car parking at least 20'.
- 5. Different types of combustibles materials not to be stored inside of the building.
- 6. No cooking arrangements allow inside the building only process food allowed.
- 7. Good Housekeeping must always be maintained.
- 8. All electrical line & equipments should be checked be Regd. Electrician.
- 9. M.C.P has to be provided.
- 10. Booster pump have to be connected with alternative power supply.
- 11. Down come with 100mm have to be provided.
- 12. Sprinkler in each corridor have to be provided.
- 13. Always kept full overhead tank and adequate quantity of must kept for fighting purposes.
- 14. No gas stove/kerosene stove allowed inside the building.
- 15. If necessary for kitchen to be placed or provided at least 10' apart from the building.
- 16. Fix up A.B.C 5kg. Portable extinguisher in each floor.
- 17. One no of Hose Reel with nozzle to be connected at all floor covering floor area.
- 18.2" pipe to be connecting from over head to ground floor 2way Fire service in left for facilities sufficient of water in case of Emergency.
- 19. Always in active in work to your submersible pump, 2Generator Emergency purposes.
- 20. All staff to be trained for primary fire fighting with the help of portable Extinguisher & Hose Reel.
- 21.4 nos. of fire buckets install at ground floor.
- 22. Route Diagram chart pasted corner of stair cases.
- 23. Another stair cases Recommendation for emergency purposes.
- 24. Always kept free all stair cases.
- 25.24 hrs. Engaged one person for look after all equipments & Gear and awareness of fire.
- 26. Any dispute arises in the land the Fire Service not to be responsible for that.
- 27. This fire safety Recommendations valid for one year from the date of issue and prior information is required for further extension the period.
- 28. N.B: Any violation of the above safety recommendations, if found, the provisional N.O.C will be treated as cancelled.
